EXTRA-CURRICULAR RALLY AT THE SCHOOL BOARD MEETING PRECEDS BOARD DECISION Legality of Extra-Curricular Activities for School Districts Under the Distance Learning Instructional Model

Minnesota Department of Education Weighs In

If your data indicates that you can be in an in-person or hybrid model, but you choose to move to distance learning, you can continue to have activities and athletics. To determine whether or not activities and athletics should be continued or discontinued, you should review the amount of spread happening with your activities participants and athletes. If your data indicates that substantial, uncontrolled community spread is occurring and/or there is a significant degree of impact on the school community, with multiple confirmed cases or large-scale outbreaks occurring among students and staff, then you **must** move to distance learning and discontinue activities and athletics for a minimum of two weeks. The language in <u>Executive Order 20-</u> 82 states that school districts must adhere to the parameters set forth in the Safe Learning Plan for 2020-2021. If the data indicates that you must move to distance learning and you choose not to move, <u>Minnesota Statutes 2019</u>, <u>section 12.21</u>, <u>subdivision 3(11)</u> gives authority to the Commissioner of Education to curtail school activities for the safety, health, and wellness of our students, staff, and community. This includes in-person learning, hybrid learning, activities and athletics.

A district or charter that is in person, hybrid, or chooses to be in distance learning can continue to host extracurricular activities. It is when a district is required to move to distance learning for health and safety reasons that they must discontinue extracurricular activities per our <u>Safe Learning Plan</u>. This would also include a district that is in distance learning by choice but then has their local COVID-19 situation essentially put them into a required distance learning model. There is no hard line or specific number that would be applied statewide as we are approach each district with a localized decision making process in collaboration with regional support teams, MDH, and MDE. For Anoka-Hennepin specifically, we do not believe that their continuation of extracurricular activities is a violation of state guidance as was reported in the news, in fact we believe that they are operating more conservatively than we believe they need to be by proactively moving to distance learning.



The Families First Coronavirus Response Act

Expires on December 31 establishes two separate and temporary paid leave laws, which run from April 1 – Dec. 31: the Emergency Paid Sick Leave Act and the Emergency Family and Medical Leave Expansion Act. These laws provide emergency paid sick leave and some partially paid parental leave protections to eligible employees who need to provide care to their children because of school and child care closures.

AHEM Hours Worked Beyond the Duty Day Survey Results

Thank you to everyone who completed the survey which made a powerful impact to the School Board at Meet and Confer Wednesday night.

Here are the results:

700 respondents to the tracking work outside duty day survey · In the span of a 7 day week:

- o 40% of respondents are working outside of their duty day 6-7 days
- o 48% of respondents are working outside of the duty day 3-5 days.
- o That means that almost 90% of respondents are working outside the duty day at LEAST 3-5 days in a given week
- 92% of respondents are working on the weekends
- On average, educators are working an extra 13 hours outside the duty day per week, but there are vast disparities as the range was between 2-44 additional hours per week.


Education Minnesota Collective Bargaining and Organizing Conference Saturday, Jan. 30, 2021
