While our current contract does not expire until June 30th, 2021, the Negotiations Team has already started planning. As part of that work, our negotiations survey will be coming out to you next week. This is earlier than the survey has been conducted in recent rounds. As the team continues preparations and identifies priorities for bargaining, we need to hear from you. Your input is vital and is just the first step in involving all of you in the bargaining process. We look forward to hearing your ideas.

Public Employees Insurance Program (PEIP) WE HAVE THE POWER!

The PEIP committee has started to meet and have heard from the State of MN's PEIP Coordinator, Education Minnesota's PEIP expert, and members of other locals who are members of PEIP.

From the period from 2010 to 2020 the PEIP pool has averaged a 3% increase. The pool is up to approx.. 200 districts, 450 total groups with more than 26,000 contracts, and approx. 54,000 members.

Delegate selection for 2021 NEA Convention

The National Education Association Representative Assembly is currently planned to be held in person July 2-6 in Denver. All active Education Minnesota members are eligible to run to be a state-credentialed delegate for the NEA RA. This means that the expenses to travel to the convention and hotel and meals will be paid by Education Minnesota. The filing period to be a state-credentialed delegate closes Dec. 11. The forms to file to be a state-credentialed delegate are located in the current issue of the Minnesota Educator newsletter. AHEM is allowed 1 delegate to be funded by Education Minnesota.

In addition, AHEM has budgeted to send a few additional members. If you are interested in attending, please either submit the form to be a state funded delegate, or email <u>valerie.holthus@edmn.org</u> to attend as a locally funded delegate.

National Education Association Conference is the primary legislative and policymaking body of the Association and derives its powers from, and is responsible to, the membership. The Representative Assembly adopts the strategic plan and budget, resolutions, the Legislative Program, and other policies of the Association. Delegates vote by secret ballot on proposed amendments to the Constitution and Bylaws. Those delegates with full voting rights elect the executive officers, Executive Committee members, and atlarge members of the NEA Board of Directors, as appropriate.

The Families First Coronavirus Response Act

Expires on December 31 establishes two separate and temporary paid leave laws, which run from April 1 – Dec. 31: the Emergency Paid Sick Leave Act and the Emergency Family and Medical Leave Expansion Act. These laws provide emergency paid sick leave and some partially paid parental leave protections to eligible employees who need to provide care to their children because of school and child care closures.
