Negotiations Notebook

What's happening with negotiations right now?

One goal for this round of negotiations is to help all members be as much a part of the process as possible. This "Negotiations Notebook" series is one part of working towards that goal.

The negotiations team is in the process of reviewing the data from the survey sent out in December. Thank you to all of you that shared your thoughts. Member responses from the survey are being used to identify the highest priorities members have for the upcoming round of bargaining. The team does not typically make the full results of the survey public as doing so may affect our ability to effectively negotiate with the district. During the remainder of the school year, the team will be seeking additional input from bargaining group members to refine goals and potential proposals to the district.

Negotiations Knowledge

In Minnesota, the bargaining process is governed by a law called the Public Employee Labor Relations Act (PELRA). PELRA establishes the right for employees to collectively bargain with school districts. It also sets the subjects that must be discussed during bargaining, like salary and benefits. State law establishes other subjects that may be discussed in bargaining while other subjects that cannot be a part of bargaining. The length of teacher bargaining unit contracts are two years in length and the beginning of bargaining 60 days before the expiration of the contract are also set forth in statute.


