

Salary schedules - pages 44 & 45 and page 55 When a Tentative Agreement is reached, typi

When a Tentative Agreement is reached, typically the first thing people look at is the updated salary schedule. Every round of bargaining includes significant time working to reach a fair and equitable financial settlement for all members. Did you know that there are actually two different salary schedules for the teacher bargaining group in the contract? The one most members are familiar with is in Appendix A on pages 44 and 45. Here is where most bargaining unit members track your salary and see what effect getting additional credits would have on your pay.

Teachers of Adult Basic Education (ABE) and Early Childhood Family Education (ECFE) are licensed teachers who work on an hourly basis through community education. ABE/ECFE teachers have separate provisions governing their positions in Appendix C of the contract. This includes a separate salary schedule on page 55 of the contract. Bringing ABE/ECFE onto the regular salary schedule has been, and continues to be, a goal for negotiations.




AHEM evaluates alternative, lower-cost health insurance: PEIP, Public Employee Insurance Program

Currently our District has what's called "self-insured" which means only district employees and their family members are part of the health care plan. Since the pool is smaller, just a few catastrophic incidents can have major impacts on your premiums. The PEIP program includes tens of thousands of insured persons, as it is a state program, all sharing the costs of health care, greatly reducing premiums. You will hear more about PEIP as an AHEM committee has formed to take charge of evaluating and investigating health insurance options.

Probationary Terminations (Pink Slips)

261 Probationary teachers have been, or will be, advised by their principals this week of their terminations, which begins the process of involuntary transfers. Transfers occur after student enrollment and sometimes course offerings are taken into consideration. Once all the transfers occur, most probationary teachers will be re-hired. High school and elementary level enrollment is projected to stay relatively constant, however, middle school numbers are projected to have some reductions in student enrollment. AHEM is offering an unemployment seminar for those who will be applying for unemployment insurance. The seminar will occur on May 12th, and registration for the seminar will be announced soon.

Government Relations Update

Minnesota's budget forecasts show a surplus of 1.6 billion, which gives lawmakers information to use for their proposals, which will be presented in early April. The Governor's budget proposal of 52.3 billion recommends \$745 million in new education spending and raising additional revenue by increasing taxes on the highest earners, those making over \$1 million for married, and \$500,000 for single filers. The tax increases are estimated at \$670 million. Conversely, the tax cuts for lower earners would amount to \$230 million to \$1 billion. Senate Republicans presented a \$51.9 billion two-year budget with no tax increases; the DFL-led House's budget targets are 52.5 billion and will release their budget proposals next week. The House, Senate and Governor will need to compromise and develop a budget going forward for the next two years by May 17, when the session is scheduled to adjourn.

Theo Keith at *Fox* 9, 3/24: "The Minnesota House passed a \$107 million summer school expansion Tuesday, targeting students who have missed months of classroom time during the COVID-19 pandemic... The bill passed 69-63 on a near party-line vote and heads to the Senate. It would provide funding for field trips, tutoring, afterschool programs, summer preschool and student mental health. The measure would also send \$29 million to districts that were forced into distance learning during the pandemic and lost students to private schools or homeschooling. Minnesota will get \$2.7 billion from the federal COVID relief law, and the governor has control over it after the legislative session adjourns."

Farmers to Families Food Donation Program



Governor Walz Appoints New Education Commissioner

Minnesota Education Commissioner Mary Cathryn Ricker has resigned after two years on the job, saying she wishes to return to classroom teaching. Ricker's last day was March 19. Governor Walz has appointed Heather Mueller as the new Education Commissioner.

In the late 1990s, social studies teachers Tim Walz and Heather Mueller had neighboring classrooms at Mankato West High School until Mueller left for a larger classroom in the school's annex.



"Mueller joined the Minnesota Department of Education as a senior director in April 2019, a few months after Walz was sworn in as governor. She became deputy commissioner in January 2020 and has been the face of the state's education response during the coronavirus pandemic, working with health officials to issue and revise guidance to public schools around when and how they can safely bring students back to school." The Education Commissioner is paid approximately \$150,000 per year, and is part of the Executive Branch of the state of Minnesota. The term expires at the end of the governor's term or if the governor vacates office.
