NEGOTIATIONS NOTEBOOK

What's going on with negotiations right now?



The negotiations team held online outreach meetings with members the last two weeks. Thank you to all of you who attended and shared your thoughts. The questions and ideas shared by members at these meetings will be used to help refine goals and priorities as we head to the bargaining table with the district this summer.

In some ways, however, the bargaining process is already starting. Over the next month or so, the Minnesota legislature will complete its work to develop a budget for the next two years. The final budget has a significant impact on the negotiations process and what can be achieved at the bargaining table. If you have not done so yet, the team urges you to sign the petition to protect and fully fund our schools at the legislature. When we go to the bargaining table, we all go together as one. Making our voices heard at the state level is one step we can all make in the larger process.

NEGOTIATIONS KNOWLEDGE

Group Insurance - Article XI, pages 18-20

Article XI covers various types of insurance coverage bargaining group members are eligible for as employees in the district. Section 2 defines the contribution the district will make towards single, family, and dual spouse coverage health insurance premiums for bargaining group members. During negotiations, it is these "district contributions" that are discussed. The amounts in the present contract have been modified by a memorandum of understanding (MOU) signed last year to increase the contributions to the levels that exist this year.

The specifics of the health insurance plan, such as which insurance provider we have, what the copays are, and what services are covered at what level are not a part of the contract. Those details are set by the district as part of the documents governing the insurance plan itself.



Boycott Marathon Petroleum Corporation, Speedway Gas Stations Urged

"The Saint Paul Building Trades announced a boycott of Speedway gas stations to call attention to Marathon's labor practices." They not only locked out their refinery workers, they are replacing them with out-of-state workers who lack training and experience.

"The company has put profits over the livelihoods of local workers and the safety of surrounding communities", said Joe Fowler, business manager of Laborers' International Union of North America (LIUNA) Local 563.

At its March 29, 2021, School Board meeting, the Anoka-Hennepin School Board approved non-renewing over 260 probationary teachers. Teachers, under contract with the District, should continue to receive benefits and compensation through the end of the 2020-21 school year, which includes full pay, plus health and dental insurance benefits, until August 30, 2021.



Please Sign the Petition!

You have likely received this postcard in the mail describing an action we can take against the decades of underfunding that have led to cuts and layoffs in our schools. About 75 percent of district funding comes from the legislature. That money funds programs for our students and funds our contracts – it's now 11.8 percent less than it was in 2003 in real dollars. Our petition puts the legislature and the governor on notice that we will not accept cuts to education. Our



goal is 50,000 educators and 90% of your worksite signing the petition statewide. Funding effects our entire community - ask parents, friends, family and other members of your community to sign too.

Government Relations Update

Aaron Balzer, AHEM Government Relations Committee Chair was among 20 people who testified on the subject of underfunding and vouchers at a Senate Hearing this week along with Heather Mueller, MN Education Commissioner, the director of the Perpich Center (which this bill would eliminate), superintendents, diversity advocacy and nonprofit leaders.

Aaron's Testimony:

School Underfunding and Vouchers

Senate Committee Testimony 4/6/21 Aaron Balzer, School Psychologist Anoka Hennepin Schools

"Esteemed members of the Senate, my name is Aaron Balzer, a School Psychologist with Anoka-Hennepin Schools for the past 20 years. Thank you for allowing me to speak today. I've worked hard with administration on school safety, improving paraeducator retention and mental health supports. It is clear to me that we have just enough to prevent the 'big behaviors' but not enough to ever get at enabling 'big learning' for disadvantaged students. Today, underfunding is at a crisis level. State education spending is now at about 12% less in real dollars compared with 2003. We can talk about any improvement we like within education but in the end, we do not have the resources to do what is needed, nor even what is required. This bill doesn't provide these resources; in fact, it cuts public schools by \$300 million.

Supporters say vouchers, or an Education Savings Account as they're called in this bill, give the option for parents to take their kids out of failing schools. The truth is, schools are not failing, the state is failing to fund our schools and expecting local taxpayers to make up for a regressive tax structure. In the 1990's, Minnesota education routinely ranked with the highest states in the country. We also ranked in the top for funding. Today, we are 23rd in educational funding. Guess where we rank in test performance? You guessed it, about 23rd. Money is required for good results. Vouchers do not raise revenue.

So, what do we need to fund? Hybrid learning has taught us that kids need timely support from their own teacher. Smaller class sizes support both emotional well-being and learning. Second, fund adequate support staff. The pandemic has exacerbated the preexisting mental health crisis we all face. There is an inadequate pipeline for training mental health staff and inadequate funding to keep mental health professionals, such as the School-Based Mental Health Therapists, in our buildings. Please fund our schools to help keep our state the national leader in education it has been known to be. Thank you."
