Considering Cashing In Your Sick Days?


Think Again!

You have recently received an email from the District regarding sick leave buy-back. Allowing the District to buy back your sick days is not in your best interest. Sick days convert when you retire at your daily rate of pay the last year you work. If you take your annual salary and divide it by 187, you will see the value of a sick day. For those at the top of the pay schedule, it is almost \$500 a day. The amount the district is offering to pay you for cashing in your days is FAR LESS than that.

You never know if you would become ill, or must care for a family member that could require you to miss work. In addition, if you were hired after July 1, 1994, you can use the value of your unused sick days (above 90) to be allocated to the Health Care Savings Plan. This could help you retire earlier knowing you would have health coverage carrying you over to the age of receiving Medicare. If you were hired before July 1, 1994 you receive a severance. Please review pages 37 and 38 in your green working agreement (contract) regarding severance pay.

As you may know, Minnesota's political leaders are nearing the end of the legislative session that will determine public education funding for the next two years.


The state budget provides about 75 percent of funding for our public school districts, so their decisions directly affect the resources we have for students, and the contracts we are able to bargain. While Governor Walz and the Minnesota House have proposed increases in education funding, the Minnesota **Senate leadership favors a package that would transfer millions of dollars to private school vouchers and lead to more education cuts and layoffs.**

That is why hundreds of Minnesotans will be gathering at the Capitol in St. Paul this Saturday afternoon at 2:00 p.m. We will be calling on lawmakers to invest in public education and other vital public services.

Lobby Days

We held our last Lobby Day for district 37 on Tuesday with Senator Jerry Newton. Representative Erin Koegel joined us after session ended. Rep. Nolan West said he may join us after session, but did not. Discussion centered around public and mental health, recruiting and retaining educators of color and infrastructure.

Senator Newton stated that there's no

chance the legislature will be wrapped up by deadline. With Minnesota slated to get 2.83 billion in onetime funding for state government from Federal Government relief, it is still unclear to him how it can be spent and there have been no talks or agreements about that. Both are supportive of fully funding public education.

Legislative Action: This is the last week of the MN Legislative session. Among the sessions of the last decade, this session is the most divided. Legislators have the task of passing substantial legislation regarding racism and police reform. There has been little compromise to date between Democratic and Republican priorities. Democrats want permanent public education increases while Republicans want to assign very limited one-time funds and move a substantial sum into education vouchers, a move that Democrats entirely reject, as it would move dollars away from public education to private schools. With a 12% reduction in overall MN Legislature spending on education over the past 20 years and a budget flush with cash, Democrats are less willing to compromise and accept the underfunding and erosion of our outstanding public school system.

FDA Action: The FDA approved the Pfizer coronavirus vaccine for kids 12-15 this week.

MN Department of Education's Safe Learning Plan will expire the first week of June. There will be a different plan starting for 2021 Summer Programming.

Member Rights Notes:

My biggest learning from the past year as Member Rights Chair can be summed up in advice I received from David Kundin: "When all else fails, read the instructions." For instance, the best way to protect your rights is to know your contract. It's 66 pages long. If you throw out the signature page, the table of contents, and the pay scale pages, it's down to fewer than 60. The contract fits in a glove compartment, a work bag, a personal organizer, or a coat pocket. Carry it around.

Why? Hundreds of hours go into its creation. It is the single most important work product that AHEM creates. It is yours. And reading it will generate questions, which generate discussions, which generate relationships, which generate empathy, which generates unity. The union isn't a thing, it's people. And your contract is what connects you to the people with whom you build your career.
