As mentioned in last week's Blast, AHEM and the district have reached a tentative agreement on a contract settlement. On Monday, November 1, in accordance with our constitution and bylaws, the Executive Board received the tentative agreement and voted to send it to members for a ratification vote.

The AHEM team believes that this tentative agreement represents a fair settlement for members. Since beginning the bargaining process in June, your AHEM team, with your support, was able to make significant progress and push the district to a settlement that better recognizes that hard work you all do every day. There are many parts to the overall agreement that provide significant benefits for our members at all stages of their careers in education.

You will receive, if you have not already, a printed summary of the parts of the tentative agreement. This summary is also available on the AHEM website: http://ahem.mn.aft.org/ The summary includes a timeline for the ratification process and copies of the Memorandums of Understanding (MOUs) that are a part of the agreement.
